- The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
- The School shall not deny admission-
  - To any child for lack of age proof.
  - If such admission is sought subsequent to the extended period prescribed for admission.
  - On the ground of religion, caste or race, place of birth or any of them.
- The School shall ensure that:
  - No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
  - No child shall be subjected to physical punishment or mental harassment;
  - No child is required to pass any board examination till the completion of elementary education;
  - Every child completing elementary education shall be awarded a certificate as laid down under Rule 21,
  - Inclusion of Students with disabilities/special needs as per provision of the Act;
  - The teachers are recruited with minimum qualifications and are provided with minimum f) salary and allowances as laid under section 23(1) of the Act.
  - The teacher performs its duties specified under section 24(1) of the Act; and
  - The reachers shall not engage himself or herself for private teaching activities.
